This Website ([www.quanteraglobal.com](http://www.quanteraglobal.com)) is operated by Quanteraglobal International B.V., with its registered office in Eindhoven, and to the extent applicable, also for the benefit of Quanteraglobal B.V., Quanteraglobal UK Ltd. or any other affiliated company, hereinafter referred to collectively as "Quanteraglobal".

Below we will explain what a cookie is and how we use cookies on this Website.

### What is a cookie?

A cookie is a small text file that is stored on your computer, tablet, phone or other device used to visit the Website. Because a cookie is stored on your computer, the website server can recognise your computer.

### Cookies on this Website

When you visit our Website, Quanteraglobal processes a number of technical details associated with the use of the Website, so that we can provide functionalities and generate usage statistics. Quanteraglobal collects and processes data concerning potential clients and visitors of the Website for the benefit of its business operations, in order to answer your questions, to inform you about, and to make available to you, products and services that may be relevant to you.

This Website uses analytical cookies that record how visitors use the Website. We use the Google Analytics software to collect information about how visitors use the website and to retrieve statistical data on this use, so that we can improve our website and make it more effective. Only with your permission, this Website uses remarketing tracking cookies. These cookies collect (part of) your IP address, type browser, operating system and application version, language settings, the page through which you came to our website and the pages of our website you visited. With the collected data we provide banners on other websites to give an incentive to the visitor to return to the Website.

Please note that you can set up your browser in such a way that no cookies are stored, that you can accept or reject each cookie or such that all cookies are deleted when you close your browser. Stored cookies can only be removed by yourself because they are stored on your computer. Consult the browser manual on how to do this.
