

Privacy Statement

This Website (<u>www.quanteraglobal.com</u>) is operated by Quantera Global International B.V., with its registered office in Eindhoven, and to the extent applicable, also for the benefit of Quantera Global B.V., Quantera Global UK Ltd, or any other affiliated company, hereinafter referred to collectively as "Quantera Global". This Privacy Statement is applicable to the processing of all personal data through the use of this website by Quantera Global.

Website

When you visit this Website, Quantera Global may register your personal data. Quantera Global will only use this personal data for the purposes described in this Privacy Statement and will do everything in its power to protect any personal data collected.
