Introduction

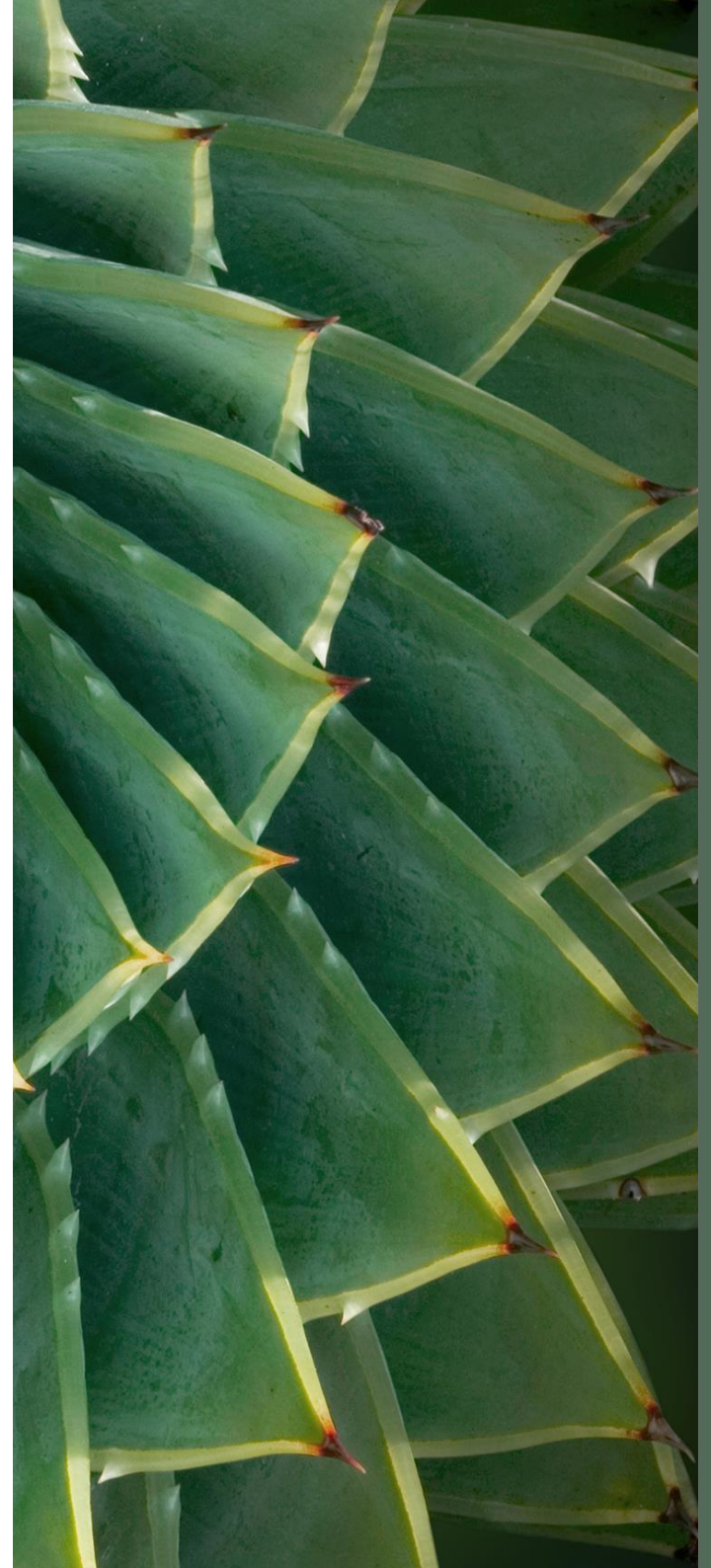
Starting activities in a country leads to all kinds of questions and requirements, like setting up a legal entity and starting to fulfill tax obligations.
